DETAILS OF TENDER**ELIGIBILITY OF COMPANY/ESTABLISHMENTS FOR PARTICIPATING IN TENDER**

The following shall be the minimum eligibility criteria for selection of bidders technically.

- (1) *The Company/Establishment must be any one of the following:*
 - (a) *Proprietorship Firm*
 - (b) *Partnership Firm*
 - (c) *Limited Liability Partnership (LLP)*
 - (d) *Joint Venture Entities*
 - (e) *A Public Limited Company or Private Limited Company having a "Certificate of Incorporation" issued under Section 7(2), Section 8(1) of the Companies Act, 2013 (18 of 2013) and Rule 18 of the Companies (Incorporation) Rules, 2014.*
 - (f) *Government-Owned Entities*
- (2) *The organization/company must possess a valid and current government-approved license/registration.*
- (3) *The organization must have a valid GST registration in its name.*
- (4) *The organization must have a PAN Card registered in its name.*
- (5) *The establishment must possess the qualifications specified in the tender document.*
- (6) *The tenderer shall prove adequate financial capacity to establish the floating bridge. Pan card, Profit & Loss Statement, Balance Sheet, Income Tax Return (ITR) and GST Registration Certificate shall be submitted along with the tender form.*
- (7) *The applicant must be an organization that fulfills the eligibility criteria specified in the rules and regulations of the Kerala Adventure Tourism Promotion Society (KATPS) pertaining to floating bridges, as enclosed with the tender document.*
- (8) *The applicant must have a minimum of one year's experience in at least one of the following sectors:*
 - (a) *Floating Bridge or Water Sports.*
- (9) *Neither the owner/ partner/ director/ or any other official of the bidder nor any of his/her close relative should not be an employee /executive or general body committee members of DTPC.*
- (10) *The applicant should not have been black listed by any organization /agency (Government/ Public/Private Sector)*
- (11) *The applicant should not have any pending criminal proceedings.*

EVALUATION METHOD

1. *The evaluation of tenders will be conducted in two stages — Technical Bid evaluation (Stage-1) and Financial Bid evaluation (Stage-2) as outlined below.*

The selection of tenders will be based on the quality of the submitted Technical Bid, legal eligibility, prior experience, financial capacity, and the amount quoted in the Financial Bid.

(a) Stage 1: Technical Bid Verification

- a(1) *Organizations meeting the eligibility criteria specified in the tender form will be considered for technical evaluation.*
- a(2) *The submitted tender form along with detailed supporting documents (Technical Bid) will first be carefully examined.*
- a(3) *The evaluation will consider the eligibility criteria mentioned in the tender form, prior experience/expertise in similar projects, submitted supporting documents, and the organization's/company's financial capacity. Marks will be awarded based on the tabulation chart mentioned in **Annexure-4***
- a(4) *A maximum of 100 marks will be awarded for the Technical Bid evaluation.*
- a(5) *Only those organizations that secure sixty five (65) marks or above in the Technical Bid evaluation, based on the criteria mentioned in the tabulation chart, will be considered for Financial Bid evaluation.*

(b) Stage 2: Financial Bid Verification

- b(1) *Organizations that score sixty five (65) marks or above in the Technical Bid evaluation will have their Financial Bids considered.*
- b(2) *As per the tender, the financial quote must indicate the license fee for the first year that the organization will pay to utilize the DTPC-approved site / facilities /arrangements for implementing the floating bridge project.*
- b(3) *The license fee proposed to be paid to DTPC must be written clearly in both words and figures in the Financial Bid form.*
- b(4) *The financial quote excluding GST/tax and including GST/tax must be mentioned separately.*
- b(5) *In case of any discrepancy between the amount written in words and figures, the amount written in words will be considered final.*

- b(6) The submitted Financial Bids will be evaluated as per the specified criteria in the tender form, and the bid quoting the legally highest license fee (financial quote) will be approved.*

AMENDMENTS TO THE TENDER

- 1. At any time before the last date for submission of the tender, DTPC may, on its own initiative or in response to requests from applicants for clarifications, issue additional information/documents and make amendments to the tender document. Any such amendments will be published only on the DTPC website and office, and will be binding on all applicants.*
- 2. To allow applicants a reasonable time to provide the information/documents to be attached as annexure to the tender, or for any other reason, the authority, at its discretion, may extend the last date for submission of the tender. Information regarding the extension of the submission deadline will be published only at the DTPC office.*

RIGHT TO CANCEL THE TENDER PROCESS

- A. The Alappuzha District Tourism Promotion Council (DTPC) reserves the right to cancel this tender process at any stage, without providing any reason, and shall not be liable to provide compensation to any applicant for any reason. If the tender is canceled for any reason or without stating a reason, applicants will not be entitled to any refund of documents submitted or any other expenses incurred.*
